At Ysgol Bryn Deva we are very fortunate to have so many supportive parents and carers. Educating children is a process that involves partnership between home and school and understands the importance of a good working relationship to equip children with the necessary skills for adulthood. For these reasons we welcome and encourage parents/carers to participate fully in the life of our school.

The purpose of this policy is to provide a reminder to all parents/guardians and visitors to our school about expected conduct so that we can work together to ensure a safe and positive school environment for our children.

Respect and concern for others and their rights.

This guidance supports the implementation of the Home-School Agreement. We expect parents and carers to show respect and concern for others by:-

- supporting the respectful ethos of our school by setting a good example in their own speech and behaviour towards all members of the school community;
- working together with teachers for the benefit of children. This includes approaching the school to resolve any issues of concern and to discuss and clarify specific events in order to bring about a positive solution;
- correcting their own child's behaviour, especially in public where it could otherwise lead to conflict, aggressive or unsafe behaviour;
- respecting the school environment, including keeping the school tidy by not littering.

In order to support a peaceful and safe school environment, the school cannot tolerate:-

- disruptive behaviour which interferes with the operation of a classroom, an office area or any other part of the school grounds;
- using loud and/or offensive language or displaying temper;
- threatening harm or the use of physical aggression towards another adult or child. This includes approaching someone else's child in order to discuss an issue or to chastise on school premises.
- damaging or destroying school property;
- abusive, threatening or defamatory phone or social network (e.g. Facebook) messages;
- smoking and consumption of alcohol or other drugs or accessing the school site whilst intoxicated;

The above behaviours on school premises will be reported to the appropriate authorities and the Governing Body may prohibit an offending adult from entering the school grounds to safeguard our school community.

We trust that parents and carers will assist us with the implementation of this policy and thank you for your continuing support.
